### MD Pictures Collaborates with Renown Hollywood Producer and Korean Filmmaker

#### Develops Music, Digital and Animation Industries

Jakarta, 14 February 2019 - PT MD Pictures Tbk (IDX: FILM) as distribution partner of the first hybrid action movie in Indonesia – Foxtrot Six, in conjunction with Rapid Eye Pictures, launched a Gala Premiere for the movie in Jakarta on 13 February 2018 at XXI Plaza Indonesia.

The 90-minute action movie featured Mario Kassar, a renowned producer in the Hollywood film industry behind Terminator 2: Judgement Day, Rambo and Basic Instinct. The Foxtrot Six movie – which is the work of art of an Indonesian young cinematographer, Randy Korompis as the Director, as well as Andreas Ian Tika, Hendy Djunaedi and Wanyi Hindrawan Pratiknyo as Producers – is believed to bring a distinctive genre for the Indonesian film industry.

“It has been an honor to be a part of the first Indonesian hybrid action movie in English. So grateful having surrounded by a great team, Randy Korompis as the director, the producers Wanyi Pratiknyo, Henry Djunaedi, Andreas Ian Tika and a group of talented actors: Oka Antara, Verdi Solaiman, Mike Lewis, Arifin Putra, Rio Dewanto, Chicco Jerikho, Julie Estelle, Edward Akbar and others. A very special thank you to my dear friend Manoj Punjabi for being a part of this.” said Mario Kassar.

Among those present at the XXI Plaza Indonesia Gala Premiere were Manoj Punjabi, CEO of PT MD Pictures Tbk, Producer Mario Kassar, Movie Director Randy Korompis, as well as a number of well-known actors and actresses such as Oka Antara, Julie Estelle, Chicco Jerikho, Rio Dewanto, Mike Lewis, Arifin Putra, Edward Akbar, Miller Khan and Verdi Solaiman. Foxtrot Six is scheduled to highlighting Indonesian theatres starting on 21 February 2019.

Manoj Punjabi, CEO of PT MD Pictures Tbk, remarked “Working together with Hollywood producer Mario Kassar on Foxtrot Six, joint ventures and film adaptation such as Sunyi is inline with our strategy for international expansion. Furthermore, MD Pictures movie – Asih, has also been well accepted in Myanmar, Vietnam and Cambodia. We are not focusing solely on film studio, but also have been operating in various related industries, such as music (through music label and publishing), digital industry and animation. In addition, MD Pictures has been growing bigger in line with the development of the Indonesian music industry through collaborations with Indonesia’s top musicians.”



A day prior to 12 February 2019, PT MD Pictures Tbk has launched Sunyi – a movie produced through an international collaboration of Pichouse Films with Xing Xing, Studio Invictus, Mixx Entertainment and CJ Entertainment. The movie which will be in theatres starting from April 2019 is an adaptation of the Korean sensasional thriller movie ‘Whispering Corridors’. The movie, originally released in 1998, has successfully been a box office as well as became the breakthrough and initiator of school-related thriller movie in South Korea.

In the event, Puti Chitara, lead singer of Barasuara music group, performed the movie’s original soundtrack – a song also called Sunyi, produced by PT MD Musik Indonesia.

PT MD Pictures Tbk, stock ticker FILM, is the first company in the film industry to go public on the Indonesian Stock Exchange. As of 14 February 2019, FILM’s stock has recorded a capital gain of 279% since its IPO (Initial Public Offering) on the 7 August 2018 with an opening price of Rp 210 per share.

Based on the data from [filmindonesia.or.id](http://filmindonesia.or.id) for 2019, since January till now there have been 15 movies released in Indonesia with MD Pictures being the biggest distributor with 4 films. Therefore, MD Pictures will have released 5 movies as of 21 February 2019, namely Tembang Lingsir, Satu Suro, Perjanjian dengan Iblis, Matt & Mou, and Foxtrot Six. It is targeted that approximately 25% of the total films being released in 2019 are by MD Pictures.
